

ADMINISTRATIVE BULLETIN NO. 78T  
MASS CASH  
NATIONAL LOTTERY DAY MASS CASH PROMOTION

SECTION 1 - PURPOSE

The purpose of this Administrative Bulletin is to outline the rules and regulations and/or procedures for NATIONAL LOTTERY DAY MASS CASH PROMOTION 2018 Promotion (“the Promotion”). The Executive Director reserves the right to amend this Administrative Bulletin if he deems it to be in the best interests of the Massachusetts State Lottery Commission (“the Lottery”).

SECTION 2 – DATES

The Promotion will run for one (1) day, July 17, 2018 only (“the Promotion date”).

SECTION 3 – ELIGIBILITY

MASS CASH wagers of \$1.00 or more, on the same ticket, purchased on the Promotion date, shall be eligible for the Promotion. Each eligible MASS CASH wager generated on the Promotion date shall be accompanied by a MASS CASH Promotional Ticket (“Promotional Ticket”). Each Promotional Ticket shall have a serial number which shall match the serial number of the MASS CASH ticket that accompanies it.

SECTION 4 - PRIZES

Up to ten (10) prizes, each in the amount of \$500.00, shall be awarded in connection with Promotional Tickets.

SECTION 5 – DRAWING PROCEDURES

1. The serial numbers of each Promotional Ticket shall be identified by the Lottery’s IT department (“Lottery IT”).
2. Ten (10) serial numbers shall be randomly selected from the Promotional Tickets as winners of a \$500.00 prize.
3. After 2:00 p.m. on July 18, 2018, the serial numbers of the Promotional Tickets selected in Section 5(2) shall be posted with the prize amounts won on the Lottery’s website ([www.masslottery.com](http://www.masslottery.com)).

4. If, for any reason, including but not limited to, technical difficulties, an Act of God, a power outage or inclement weather, the Lottery is unable to identify, select or post the serial numbers referenced in Sections 5(1) and 5(2) as scheduled, the Lottery shall comply with Sections 5(1) through 5(3) on the next business day when compliance is possible.
5. The Lottery shall not be responsible for any data entry, typographical or transmission errors or the like or for consequences or claimed damages arising out of any such errors.

#### SECTION 6 – CLAIMING A PRIZE

1. Players with tickets matching the serial numbers selected in Section 5(2) must claim their prizes at a Lottery regional office. Lottery regional office locations are posted on the Lottery's website ([www.masslottery.com](http://www.masslottery.com)).
2. To claim a prize in connection with Section 5(2), the winning ticket holder must present the original Promotional Ticket, valid photo identification and proof of valid Social Security number.
3. All prizes won as a result of the Promotion must be claimed by August 17, 2018.
4. Prizes not claimed by August 17, 2018 shall be forfeited.
5. Prize checks shall be mailed approximately two weeks after the prize has been claimed. Actual prize amount will be less applicable taxes and withholdings.


#### SECTION 7 – GOVERNING LAW

In purchasing a ticket, a player agrees to comply with and abide by the laws of the Commonwealth of Massachusetts, all rules and regulations and final decisions of the Lottery, and all procedures established by the Executive Director concerning the Promotion. No MASS CASH ticket shall be purchased by, and no prize shall be claimed by or paid to any of the following persons: any member or employee of the Lottery or to any spouse, child, brother, sister or parent residing as a member of the same household in the principal place of abode of any member or employee of the Lottery. No MASS CASH ticket shall be purchased by any person under the age of eighteen.

SECTION 8 – EFFECTIVE DATE

The effective date of this Administrative Bulletin shall be July 17, 2018.
