


ADMINISTRATIVE BULLETIN NO. 479PPP
MASSACHUSETTS STATE LOTTERY
"MA LOTTERY 2ND CHANCE APP" PROMOTION

The purpose of this Administrative Bulletin is to outline the rules and regulations for the Massachusetts State Lottery "MA Lottery 2nd Chance App" Promotion. The manner in which the promotion is conducted shall be consistent with the Official Rules attached to this Administrative Bulletin.


The Executive Director reserves the right to amend this Administrative Bulletin if he deems it is in the best interest of the Lottery to do so.

The effective date of the Administrative Bulletin shall be February 4, 2019.

**Massachusetts State Lottery Commission's
"MA LOTTERY 2ND CHANCE APP" Promotion**

Official Rules

1. GENERAL: By participating in the "MA Lottery 2nd Chance App" Promotion ("the Promotion"), sponsored by the Massachusetts State Lottery Commission ("the Lottery"), located at 60 Columbian Street, Braintree, MA 02184, the entrant acknowledges and agrees to be bound by the Official Rules ("the Official Rules" and by all decisions of the Executive Director of the Lottery, whose decisions are in his sole discretion and are binding and final. Failure to comply with the Official Rules will result in disqualification from the Promotion. The Promotion encompasses the time period beginning with the launch of the MA Lottery 2nd Chance application on September 1, 2016 and ending at 11:59 PM on February 28, 2019 ("the Promotion Period"). All times in the Promotion refer to Eastern Time.

2. ELIGIBILITY: The Promotion is open only to legal United States residents who 1.) are registered account members of the Lottery's Red Carpet VIP Club ("VIP Club") and who 2.) have scanned or manually entered a non-winning ticket through the "MA Lottery 2nd Chance" application on or before 11:59 PM on February 28, 2019 (the Promotion Period). These members shall be known as "eligible account members". All members of the VIP Club and application users must be 18 years of age or older to register to win a prize. An individual who turns 18 years of age during the Promotion Period shall only be eligible for the Promotion Period on and after the date that the member reaches 18 years of age. Individuals who are not currently registered VIP Club members and/or who are registered VIP Club members but have not scanned or manually entered a non-winning ticket through the "MA Lottery 2nd Chance" application during the Promotion Period may become eligible by becoming a registered VIP Club member and/or by scanning or manually entering a non-winning ticket through the "MA Lottery 2nd Chance" application during the Promotion Period.

Employees of the Lottery and family members of employees of the Lottery, including any spouse, child, brother, sister or parent residing as a member of the same household in the principal place of abode of any employee of the Lottery, and employees of the Lottery's advertising agency, are not eligible to enter the Promotion or to win a prize as a result of the Promotion. Employees of Scientific Games International, Inc. and its affiliated companies (collectively, SGI) and family members of employees of SGI, including any spouse, child, brother, sister or parent residing as a member of the same household in the principal place of abode of any employee of the SGI are not eligible to enter the Promotion or to win a prize as a result of the Promotion.

3. HOW TO ENTER: There is one (1) method of entry for the Promotion, as follows: To participate in the Promotion, entrants must 1.) be a registered member of the Lottery's Red Carpet VIP Club and must 2.) have scanned or manually entered a non-winning ticket through the "MA Lottery 2nd Chance" application on or before 11:59 PM on February 28, 2019. Registered VIP Club members who have previously scanned or manually entered a non-winning ticket through the "MA Lottery 2nd Chance" application since September 1, 2016 are already eligible for the Promotion. Individuals who are not currently registered VIP Club members and/or who are registered VIP Club members but have not scanned or manually entered a non-winning ticket through the "MA Lottery 2nd Chance" application during the Promotion Period may enter by becoming a registered VIP Club member and/or by scanning or manually entering a non-winning ticket through the "MA Lottery 2nd Chance" application during the Promotion Period. The player account information that is submitted by users to register their application will not be shared and will be used solely for the purpose of notifying the prize winners of the Promotion.

Each eligible account member will receive one entry into the Promotion.

The Lottery reserves the right to disqualify entries that violate the terms of any of the agreements by which the entrant has agreed to abide as an entrant of the Promotion.

4. PRIZES: Up to ten (10) prizes, each in the amount of \$1,000, shall be available to be awarded as a result of the Promotion. Each prize shall be a cash prize of \$1,000. There shall be no substitutions. Transfer of the prize is prohibited. Prize checks will be mailed to the address on the winners' VIP Club Accounts within two weeks of notification. All applicable federal, state and local taxes, and expenses, costs or fees associated with the acceptance and/or use of the prize shall be the sole responsibility of the winner.

5. SELECTION OF WINNERS: Ten (10) winners shall be randomly selected by the Lottery from all eligible account members identified during the Promotion Period. The winners shall be selected using a computer generated algorithm to randomly select ten (10) identification numbers from all eligible application users. The users ranked 1 through 10 shall be eligible to receive a \$1,000 cash prize. All remaining users in the file ranked 11 through 100 shall be alternates, and if necessary, chosen in sequential order. Winners shall be selected within three (3) business days following the end of the Promotion Period. The winners will be notified by the Lottery within two (2) business days of the drawing date that they must complete a claim form and provide proof of his/her Social Security number. Winners' names shall be announced on the Lottery's website at www.masslottery.com. If any prize notification is undeliverable, or in the event of non-compliance with any of the Promotion rules, the prize shall be forfeited. The Lottery shall select an alternate winner for any prize that is forfeited. It shall be the sole responsibility of each entrant to notify the Lottery if his or her contact information changes. The Lottery shall not be responsible for false, incorrect, changed, incomplete or illegible contact information. Each eligible account member is limited to a maximum of one prize.

6. PRIVACY AND PUBLICITY: Personally identifiable information that is submitted by an entrant as part of the Promotion shall be used to administer the Promotion, select the prize winners and fulfill the prizes, and will be treated in accordance with the Lottery's privacy policy, available at <http://www.masslottery.com/privacy.html>. Except where prohibited, participation in the Promotion constitutes the winner's permission to use his/her name, likeness, voice, opinions, biographical information, city and state of residence for promotional purposes in any media without further payment or consideration.

7. GENERAL CONDITIONS: If the Promotion is not capable of running, as planned, for any reason, including infection by computer virus, bugs, tampering, and unauthorized intervention, fraud, technical failures, or any other causes beyond the control of the Lottery which corrupt or affect the administration, security, fairness, integrity of the game or Promotion, the Lottery reserves the right in its sole discretion to disqualify any individual it believes has tampered with the Promotion process, and/or cancel, terminate, modify or suspend the Promotion, without any consequence whatsoever to the Lottery or to any VIP Club member. The Commonwealth of Massachusetts, the Treasurer and Receiver General, the Lottery, and their Commissioners, directors, agents and employees of any of the foregoing (i) assume no responsibility for any error, omission, interruption, deletion, defect, incorrect information, printing and production errors, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alternation of, entries, (ii) are not responsible for any problems or technical malfunction of the VIP Club, the MA Lottery 2nd Chance application, any mobile networks, any telephone network or lines, computer on-line systems, servers, or provider, computer equipment, software, failure of any email to be received by the Lottery on account of technical problems, human error or traffic congestion, or any combination thereof, including any injury or damage to the entrant or any other person's mobile phone or device related to or resulting from participation in the Promotion.

8. RELEASE AND LIMITATIONS OF LIABILITY: By entering the Promotion, each entrant agrees on behalf of herself/himself and each of her/his heirs, executors, and administrators (a) to release and hold harmless the Lottery, its respective constitutional office, subsidiaries, affiliates, officers, directors, agents and employees (collectively the "Released Parties") from any liability, illness, injury, death, loss, litigation, or damage that may occur, directly or indirectly, whether caused by negligence or not, from

such entrant's participation in the Promotion and/or his/her acceptance, possession, use, or misuse of prize or any portion thereof (including any travel related thereto); (b) that Released Parties have neither made nor are in any manner responsible or liable for any warranty, representation or guarantee express or implied, in fact or in law, with respect to any prize, including, without limitation, to such prize's quality or fitness for a particular purpose; and (c) to be bound by these Official Rules and to waive any right to claim any ambiguity or error therein or in the Promotion itself, and to be bound by all decisions of the Lottery, which are binding and final. Failure to comply with these conditions may result in disqualification from the Promotion at the Lottery's sole discretion.

9. DISPUTES/CHOICE OF LAW: Except where prohibited, each entrant agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with the Promotion or any prize awarded shall be brought and are subject to the exclusive jurisdiction of the state or federal court situated in the Commonwealth of Massachusetts, (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, but in no event attorneys' fees; and (3) no punitive, incidental, special, consequential or other damages, including without limitation lost profits may be awarded (collectively, "Special Damages"), and (4) entrant hereby waives all rights to claim Special Damages and all rights to have such damages multiplied or increased. Massachusetts law, without reference to Massachusetts' choice of law rules, governs the Promotion and all aspects related thereto.

10. 11. ODDS OF WINNING: Odds of becoming a winner of the Promotion are wholly dependent on the total number of eligible entries. There shall be up to ten (10) winners.

12. MISCELLANEOUS: The invalidity or unenforceability of any provision of these Official Rules or the Required Documentation will not affect the validity or enforceability of any other provision. In the event that any provision of the Official Rules or the Required Documentation is determined to be invalid or otherwise unenforceable or illegal, the other provisions will remain in effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained therein. Entrants agree to waive any rights to claim ambiguity of these Official Rules. Headings are solely for convenience of reference and will not be deemed to affect in any manner the meaning or intent of the documents or any provision hereof. In the event there is a discrepancy or inconsistency between disclosures or other statements contained in any Promotion-related materials, privacy policy, and/or the terms and conditions of the Official Rules, the Official Rules shall prevail, govern, and control, and the discrepancy will be resolved in the Lottery's sole and absolute discretion.
